3. Disclosure of Data to Third Parties

Your personal data will only be disclosed to third parties or otherwise transmitted if this is necessary for the purpose of processing the contract. This particularly includes disclosure to service providers we use to process your booking (e.g., payment service providers, shipping companies).

Legal Basis:

Disclosure is based on Art. 6(1)(b) GDPR and Articles 7-10 DSG.

4. Data Storage and Deletion

5. Your Rights

You have the right to:
